## Massive Online Open Course (MOOC)

### What is the MOOC?

Massive Online Open Course (MOOC) is the third and last training stage of the EU-FamPro project. It is a self-paced course which will take place fully online on a self-learning platform EduOpen. The MOOC was devised to increase legal professionals' competence and understanding in the field of EU private international family law as well as to foster their interaction and cooperation.

### Who can attend the MOOC?

The MOOC will be open to lawyers, judges, mediators, and notaries. Prior experience dealing with EU private international family law cases is not required.

### Schedule and contents of the MOOC

MOOC will start on **15 November 2022**. It is planned that the MOOC training offers at least 5 weeks of study effort, while the participant may choose the starting date within the designated period starting with 15 November and ending on **9 March 2023**. It will consist of 9 segments, including five course units. The contents of the MOOC will follow the main private international law questions dealt with in the Twin Regulations: jurisdiction, applicable law, and recognition and enforcement. In addition, it will delineate their respective scopes of application as well as their interaction with the Succession Regulation.

The course units will incorporate learning-by-doing methodology and will include various uploaded materials, including videos of the lessons, teaching materials, self-learning materials, and self-evaluation tests.

#### Main Course Materials

Various scientific publications and documents will be provided in English as well as in the languages of the Project partner countries.

#### Course Units

UNIT 1. **The Twin Regulations: adoption and scope of application** (1 week) (led by University of Almería)

UNIT 2. **Jurisdiction in the Twin Regulations** (1

week) (led by University of Camerino)

UNIT 3. **Applicable law in the Twin Regulations** (1 week) (led by Law Institute of the Lithuanian Centre for Social Sciences)

UNIT 4. **Recognition and enforcement under the Twin Regulations** (1 week) (led by University of Ljubljana)

UNIT 5. **Succession Regulation and its interplay with the Twin Regulations** (1 week) (led by Rijeka University)

**Video Simulations Section** (video simulations of relevant cases)

#### Final Section

**Final Test** (the test will take the form of a multiple-choice quiz and will include questions from all five units)

With these objectives in mind, the trainees will be exposed to various training styles as well as views from different Member States and will be able to interact with all the Project partners in the Forum.

*Completing the E-Training Course and Earning the Attendance Certificate*

By participating in the MOOC and completing the planned activities, each participant can obtain a Certificate of Completion. The e-learning platform will automatically verify the necessary requirements to generate the certificate of completion: the course attendance progression and the score achieved in the final test. Depending on these criteria, the trainee will be awarded the Certificate with the accomplishment of: "successfully completed" (50 to 69 %), "successfully completed with Honors" (70 to 89 %), or "successfully completed with distinction" (90 to 100 %). Upon a positive result of this automatic verification, the e-learning platform will generate the Certificate of Completion in the MOOC, which will become available to the trainee.
