## Contents and Schedule of the E-Training Course

**E-Training** course starts on 4 April 2022 and ends on 9 May 2022 and is delivered via the Moodle platform. It is structured in units dedicated to specific topics on cross-border cases in matters of matrimonial property regimes and property consequences of registered partnership, and their interplay with succession matters.

**Each of the 5 units** includes video interviews with practitioners, video lessons by academic staff, lecture notes, article-by-article commentary, conceptual maps, case summaries, useful links, quizzes, etc. The course content will be made gradually available to the participants to allow steady progress through the units.

In addition to the course content which will be accessible to the participants at all times, the E-Training also consists of **7 live webinars** in which participants will be given an opportunity to actively contribute by exchanging experience in the field and discussing practices in different EU Member States.

If you are a legal practitioner looking to expand your understanding of **European Union family and succession law**, you should join our e-training. The EU-FamPro team prepared an **online free-of-charge course** based on innovative and practically oriented approach specially designed for legal professionals.

The course will be open to legal professionals from the EU Member States from which Project partners originate (**Croatia, Italy, Lithuania, Slovenia** and **Spain**), including attorneys, judges, mediators and notaries.

The Project seeks to achieve at least **30% of the participants to be women** working in the mentioned EU Member States.

## Completing the E-Training Course and Earning the Attendance Certificate

By participating in the E-Training Course and successfully completing the planned activities within that Course, each participant will obtain an Attendance Certificate.

The e-learning platform is designed to automatically verify the following necessary requirements to generate the Attendance Certificate:

- the level of participation in and completion of the training activities, and
- the score achieved in the final test.

These requirements are measured by the following evaluation system criteria:

1. total time spent at the platform by an individual trainee,
2. percentage of materials opened and used by an individual trainee,
3. speed in completing the entire course by an individual trainee, and
4. score achieved in the final test by an individual trainee.

The first three criteria bear 20 points each while the last one bears 40 points, amounting to maximum of 100 points. The minimum points to complete the E-Learning Course is 50. Depending on these criteria, a trainee will be awarded the Attendance Certificate at one of the three levels of accomplishment: “successfully completed”, “successfully completed with honours” and “successfully completed with distinction”. Upon a positive result of this automatic verification the e-learning platform will generate the Attendance Certificate in the E-Training Course, which will become available to the trainee by clicking on the corresponding icon. The trainee will be able to print or to save in the pdf format her or his Attendance Certificate.
